## CONDITIONS OF BOOKING FOR DRIFT END COTTAGE

- Bookings are for short-stay holiday rental only
- A deposit of £150 per week (£100 for short breaks) is required to secure booking. The balance is to be paid eight weeks before the holiday start date. The full rental is payable immediately if the booking is made within eight weeks of the holiday start date. In case of cancellation, no monies paid can be refunded unless the property is re-let for the same period and rate.
- Maximum letting period is two weeks
- The number of persons occupying the property overnight must not exceed four.
- Bookings are from Saturday to Saturday. The property will be available from 4pm on the first day, and clients are asked to leave the property by 10am on the last day of their stay.
- Clients are required to take all reasonable care of the property and its contents, and to leave it clean and tidy at the end of the holiday period. A charge will be made for damage or breakage, unless minor, and for any special cleaning required.
- The owners of the property do not accept liability for any loss, damage, sickness or injury caused to the client, his party or possessions

### Please note:

- There is a pedestrian right of way at the front of the cottage to/from the neighbouring property.
- The track to/from the Drift End Cottage parking space must remain clear to allow vehicular access to the neighbouring property.
